Me	ethodology	Telephone numbers were first drawn randomly from the residential telephone directories. After filtering duplicated numbers and mixing the remaining ones, telephone surveys were conducted by interviewers

Survey Findings

1. Respondents' usage of contact lens solution

Over 50% of respondents were wearing daily or bi-weekly disposable contact lenses

Q: What sort of contact lenses are you wearing?

3. Dry eye symptoms in relations to wearing contact lenses

Close to 70% of respondents had experienced sore eyes when wearing contact lenses

4. Respondents' awareness of usage of contact lens solution in managing dry eye symptoms

56% of respondents knew that not all contact lens solution could help improve dry eye symptoms

Q: Do you know that not all contact lens solution can help improve dry eye symptoms?



86% of respondents hope that the contact lens solution could keep their eyes moist and they would not feel uncomfortable for wearing the lenses for a long time

61% of respondents knew that their eyes would feel uncomfortable if their contact lens solution did not match with their contact lenses

Only 10% of respondents had used Silicon Hydrogel contact lenses with high oxygen permeability before

Conclusion

Respondents' concern of contact lens solution

- 92% of respondents required their contact lens solution to be safe & reliable.
- With regard to disinfection power, 96% of respondents considered an ability to eradicate bacteria, fungi and amoeba was essential to contact lens solution.
- With regard to safety, close to 90% of respondents considered "safe ingredients" and "safe production process" were essential to contact lens solution.
- 69% of respondents had trust in contact lens solution produced in the U.S. None had confidence in the products produced in mainland China.

Dry eye symptoms in relations to wearing contact lenses

- Close to 70% of respondents had experienced sore eyes when wearing contact lenses. 55% of those who had dry eyes symptoms said the symptoms always or sometimes came up.
- 52% of respondents had experienced that their eyes were so dry that the contact lenses dropped out or moved.

Respondents' awareness of usage of contact lens solution in managing dry eye symptoms

- 56% of respondents knew that not all contact lens solution could help improve dry eye symptoms.
- 86% of respondents hope that the contact lens solution could keep their eyes moist and they would not feel uncomfortable for wearing the lenses for a long time.
- 61% of respondents did not know that their eyes would feel uncomfortable if there was an incompatibility of lenses and solution.
- Only 10% of respondents had used the high oxygen permissible Silicon Hydrogel contact lenses before.
- 93% of respondents did not know that not all contact lens solutions were compatible with Silicon Hydrogel contact lenses.
